The BSCMR would like to invite submissions of abstracts for the CMR Investigators' Prize. Four abstracts will be chosen to be presented by the authors at the meeting during the session at 14:55 hours, and the winner will be announced at the end of the day. The abstracts should be a maximum of a single A4 page, and may contain text and graphs/images. They must be submitted, preferably as a PDF file (or as a Word file), by email to: office@bscmr.org by **Friday 10 February 2012**. The authors will be notified over the following few weeks, and those not selected for oral presentation will be invited to display a poster at the meeting. Prizes for the top four abstracts will be presented on the day.
